## Dear Friends, Neighbors & Constituents,

It hardly seems possible that 2007 is drawing to a close, but I guess we have to accept reality and forge ahead! This year's legislative session will be a short one devoted to budget and revenue items. We have less new revenue to work with this year—\$369 million—so I expect competition to be keen for new programs or expansions. Health Care Reform will take center stage this session as the Governor rolls out a proposal for universal coverage. I hope to play a major role in ironing out some agreements in this area, which looks like it will be very difficult. Much of my questionnaire this time is devoted to getting your opinions on health care, and I hope you will fill out the attached survey, detach, fold, affix stamp and send it back to me before I leave for the session on Jan. 14th. During the interim I have been busy as the Chairperson of the Health and Human Services Committee, and as a member of the Health Coverage for New Mexicans Task Force, where we examined various coverage proposals, the escalating costs of health insurance and care, the shortage of doctors and other professionals, as well as Medicaid and other programs. A centerpiece of this work was a study done by an outside consultant, Mathematica, which concluded that the cost of going to a system that provides health coverage for all New Mexicans would be only incrementally more expensive than the present system. In the present system, 432,000 New Mexicans do not have health insurance!

The legislature will also take up some unfinished ethics and campaign finance business in January, following on last session's failure to act favorably on several important measures. Two of the bills which died last time (by the slimmest of majorities) were mine-limits on campaign contributions and open legislative conference committees. To keep the ball rolling, the Governor reconvened the Ethics Task Force which, once again, recommended these measures as well as others to establish an Ethics Commission, expand voluntary public campaign financing, provide legislative compensation and require more lobbyist disclosure. He'll put these measures on his agenda this time and I'll be there, fighting for their passage.

#### **CREDIT SECURITY FREEZE**

SB 448 & 165 allow consumers to freeze their credit report to avoid identity theft by mail thieves or others who can access these records and open accounts in their name. For details on how you can do this go to my web site at **www.dedefeldman.com**. Special thanks to the AG, AARP and other advocates who helped push this through.

#### SUSTAINABLE BUILDING TAX CREDIT

SB 543 provides an income or corporate tax credit for the owners of new residential or commercial buildings built to LEED or Green Build New Mexico standards.

#### **AUTISM PROGRAMS**

SB 164 eventually channeled \$2 million to various programs for children with autism, to enable better diagnoses, provide skill building, and support hard-pressed parents.

#### THE SMALL EMPLOYER INSURANCE PROGRAM

SB 428 fixed the program so that small businesses and non-profits could join the plan immediately even if they already had insurance. Previously membership was available only to those who didn't offer insurance or who dropped their insurance for one year before joining. **HPV COVERAGE** 

SB 407 mandates that insurance companies cover Human Papilloma Virus immunizations, which have recently been determined to prevent HPV and reduce the risk of cervical cancer in young girls, if they get the shots when they're between the ages of 9 to 14.



#### NEW MEXICO GROWN FRESH FRUITS & VEGETABLES

SB 90 allocates the funds for schools to provide NM produce and fruit to schoolchildren. The bill was originally statewide but I was able to get funds for a pilot project in the Valley cluster. Kids in these schools now have a fresh snack twice a week. It's a win/win for local farmers and good health. Diabetes and obesity are becoming big problems with school kids.

#### TRAILS LIABILITY

SB 486 will spur the use of trails for exercise and recreation by shifting the liability for any injuries from the MRGCD to trails managers.

#### **CAPITAL OUTLAY**

Last year I was able to obtain \$3.2 million for improvements to District 13 schools, libraries, parks, museums, housing and arts projects. Public School projects included, Valley, Garfield, Taft, Reginald Chavez, Duranes, Griegos, La Luz, Alvarado, Amy Biehl, Chaparral, Douglas Macarthur, Los Puentes, Los Ranchos, and Mission Avenue. Neighborhood projects included 4th St., Sawmill Land Trust, Los Duranes Park, Los Ranchos Open Space, Montano railroad station, quiet crossings, 12th and Menaul, West Side Open Space Center, Ditches with Trails, and the Rio Grande Nature Center. Museums and cultural facilities included VSA Community Center, Griegos library, Indian Pueblo Cultural Center, Alb. Museum, Natural History Museum, Keshet Dance, and the Working Classroom.
